The individual report has been re-styled following feedback from students, parents and staff received during the Assessment Review conducted last year.

The first change is the introduction of an “Attitude to Learning” grade to replace the “Behaviour for Learning” statements. An explanation of these can be found on every report. Further changes relate to KS4 and 5 students only.

- Reports will contain a benchmark grade which will use the relevant examination grading system (e.g., 1-9 at GCSE, A*-E at A-level).
- Reports will only contain a predicted attainment grade.
- At KS4, the predicted 7, 8 and 9 will be reported as 7+. PPE results will contain the full range of 1-9 grades.

The final changes relate to KS3 students only.

- Students will receive a current attainment descriptor. An explanation of these can be found on every report. Students will be assessed using a Point in Time Assessment approach. This will measure their understanding of the curriculum which has been taught up to that point. Each subject has an age-appropriate curriculum which has been designed to support all children develop and improve their knowledge and skills of the subject. The contents of this curriculum can be found on the school website. For information on how your child can improve, please check the feedback in their books.
- Students will not receive a Benchmark until they start KS4.
